BACKGROUND

The State Power Sector PSUs intends to undertake CSR (Corporate Social Responsibility) initiative on consortium mode to provide free residential medical coaching to students from the economically weaker section of the society aspiring for admission in to Medical Colleges. This would help the underprivileged talented students to excel their career in the field of Medical Science who could not afford for the expenses in preparatory coaching. This initiative will benefit the deserving students from various parts of the state for free advance residential coaching environment at Bhubaneswar. The faculties of high repute and well experienced shall be engaged for ensuring optimum result. With the scope of increasing Medical seats in various Medical Colleges in the State, this free coaching program will definitely boost in creating additional pool of Medical Practitioners for the entire State of Odisha, especially from the backward Districts. OPTCL being the Nodal Organisation shall coordinate the entire project.

SCOPE OF THE PROJECT

- 1. Coaching shall be extended to 50 students at initial phase and the same will be increased next year after observing the outcome.
- 2. The Coaching will be residential in nature at Bhubaneswar for a period of 10 months and all the cost pertaining to the cost of lodging, boarding, coaching and other operational expenses shall be covered under this project.
- 3. Students will be selected by the agency through a structured method in consultation with the Nodal officer.
- 4. While selecting the Students for this purpose, emphasis shall be given to select the students from areas where project/site of the Power Utilities exists. However, concerned District of those areas shall be taken in to consideration.

- 5. The implementing agency shall coordinate with the District Administration authorities while mobilizing the students.
- 6. Family income of the students must not be more than 6.00 Lakhs per annum.
- 7. +2/12th Class Science students from 2015-16 and 2016-17 batch are eligible for availing this coaching.
- 8. Students should have secured prescribed minimum marks in +2/12th classes.
- 9. Faculties of high repute and experience with excellent track record of result need to be engaged.
- 10. Apart from medical coaching, the implementing agency shall take overall responsibility for activities/programs to boost the morale and confidence of the students.
- 11. The implementing agency shall ensure registration of the students for the required entrance examinations.
- 12. The faculties shall impart coaching at the residential center of the students.
- 13. Study materials and library facility shall be provided to the students.
- 14. Healthy and hygienic food shall be provided in-house.

SELECTION OF AGENCY

After receiving the proposals, the concerned Agencies will be invited for making presentation regarding their planned proposal along with the cost breakup for rolling out this Project successfully. The selection committee shall evaluate each proposal and finalize the agency.
