The economically weaker students will get exposure to sophisticated and quality coaching environment by a National repute Coaching Institute with free of cost. With the scope of increasing Medical seats in various Medical Colleges in the State, this free coaching program will definitely boost in creating additional pool of Medical Practitioners for the entire State of Odisha, especially from the backward Districts. OPTCL being the Nodal Organisation is coordinating the project.

#### **SCOPE OF THE PROJECT**

- 1. Coaching shall be extended to 50 students in 2018 batch and the No. of students may be increased coming year after observing the outcome.
- 2. The Coaching will be residential in nature at Bhubaneswar and all the cost pertaining to the cost of lodging, boarding, coaching, study material and other operational expenses shall be covered under this project.
- 3. Students will be selected by the Coaching Institute through a structured method in consultation with the Nodal Agency.

- 4. While selecting the Students for this purpose, emphasis shall be given to select the students from areas where project/site of the Power Utilities exists. However, concerned District of those areas shall be taken in to consideration.
- 5. Family income of the students must not be more than 6.00 Lakhs per annum.
- 6. +2/12th Class Science students from 2016-17 and 2017-18 batch are eligible for availing this coaching.
- 7. Students should have secured minimum percentage of marks in +2/12th classes as given below.

General/OBC	70%	60%
SC/ST	60%	50%

- 8. Faculties of high repute and experience with excellent track record of result need to be engaged.
- 9. Apart from medical coaching, the coaching institute shall take overall responsibility for activities/programs to boost the morale and confidence of the students.
- 10. The coaching institute shall ensure registration of the students for all the required National Level Medical Entrance Examinations like NEET, AIIMS etc.
- 11. Study materials and library facility shall be provided by the coaching institute to the students.
- 12. Healthy and hygienic food shall be provided in-house by the coaching institute.

### **SELECTION OF COACHING INSTITUTE**

After receiving the proposals, the concerned Coaching Institutes will be invited for making presentation regarding their planned proposal along with the cost breakup for rolling out this Project successfully. The selection committee shall evaluate each proposal and finalize the Coaching Institute.
