No.**1377** dated **07.09.2016**

1. For and on behalf of Odisha Power Transmission Corporation Limited, the Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar invites percentage rate bids in **Single Cover system** for the works through e-procurement as detailed in the table. The bid should be submitted only online in the <http://tenderorissa.gov.in> by eligible class of contractors for construction of building works registered with the State Government and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways having registration for execution of civil works can participate in the works on production of definite proof from the appropriate authority. But successful bidder other than State/ MES/Railway/ CPWD equivalent rank has to be registered under the State P.W.D. before signing the agreement. The bidders should have the necessary Portal Enrolment (with his own digital signature certificate).

2. The bidders may submit bid for the works as per the following table :-

- Bid documents consisting of specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website <http://tenderorissa.gov.in> as specified at column-8 above except on Sundays and public holidays.
- Bids must be accompanied by and Earnest Money Deposit / Bid Security of the amount @ of 1 % of the estimated cost specified for the work in shape of **Deposit Receipt of Schedule Bank /N.S.C. / K.V.P. / Post Office Savings Bank Account /Post Office Time Deposit Account** pledged in favour of EE,CWD-I,OPTCL,Bhubaneswar and will have to be in any one of the forms as specified in the bidding document. Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to furnish 2 % of the amount put to tender as Bid Security.
- The Bid documents will be available in the <http://tendersorissa.gov.in> from **11.00 Hours of 12.09.2016 to 21.09.2016 up to 17.00 Hours.**
- The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
- Bids shall be received only **“online”** on or before **17.00 Hours of 21.09.2016**
- The Bids received “on line” shall be opened at **11.30 Hours on 26.09.2016** in the office of the Superintending Engineer (civil), Civil Works Circle, OPTCL,Bhoinagar,Bhubaneswar, in the presence of bidders who wish to attend Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day.

9. The bidders shall furnish the self-attested copies of the documents as mentioned in clause no 26 of the DTCN. They may go through the outright rejection criteria as mentioned in clause no 111 of the DTCN.
10. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimate cost put to tender. In such an event the bidder who have quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e. estimate cost put to tender minus the quoted amount as Additional Performance Security in Shape of Demand Draft/Term Deposit Receipt pledge in favour of **EE,CWD-I,OPTCL,BBSR** in the sealed envelope along with the Tender Cost & EMD. Failing which the bid will be rejected.
11. Exemption holder like SC/ST contractors should submit attested copy of caste certificates and an application for rate preference for availing the facilities. Engineering contractors should submit an attested copy of Engineering degree/diploma certificate and an undertaking in shape of an affidavit that he has not availed concession 3 (three) times in the current financial year and the PH bidders should produce their original registration certificate stating the fact of physically handicapped by their registration authority with the bid, failing which they will not get price preference as per rule.
12. For a particular work a bidder can submit only one set of tender paper. Submission of more than one set of tender paper by a bidder for a particular work will be liable for rejection of all such tender paper of the concerned bidder.
13. The packet super scribing the name of the work and containing cost of bid document & EMD/Bid Security in original and other documents may be submitted in the office of the undersigned after bid closing date **21.09.2016** and on or before 17.00 Hours on dated **24.09.2016** during office hours on working days failing which the bid will be rejected.
14. The cost of bid documents in shape of demand draft drawn in favour of Superintending Engineer, Civil Works Circle, OPTCL, Bhubaneswar on any Scheduled Bank mentioned at column-6 above, payable at Bhubaneswar **separately** towards cost of each tender. **Non Submission of Cost of Bid Document and Bid Security within the designated period shall debar the defaulting bidder from participating in the online bidding system & his portal registration shall be cancelled. His name shall also be informed to the Registering Authority for cancellation of his registration.**

15. The bidders should have successfully completed at least a single **similar nature of work** worth tender value of **50% of estimate cost for each work** in any during the last three financial years. The bidders failing to produce authenticated document in support of work experience from competent authority is liable for rejection. Experience certificate from any Private Organisation will not be entertained. Experience certificate furnished below the rank of Executive Engineer of Government Department/Public Sector Undertaking will not be accepted.
16. The Bidders are required to produce original documents for verification which are submitted online within 5 days of opening of the tender, **failing which the bid will be summarily rejected.**
17. The bidders are to submit an affidavit certifying the documents & information furnished by them are genuine.
18. Before tendering, the bidder may visit the sites and satisfy himself, as no claim what-so-ever shall be entertained for any alleged ignorance, after the tender is opened.
