GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]

1. Scope of the contract:

The scope of work covers the following activities.

- a)Pollarding of trees along the existing line as per I.S.
- b)Replacement of missing tower members.
- c)Replacement broken/damaged insulators.
- d)Restringing of conductor and earth wire, if necessary.
- e) Fixing of vibration dampers, execution of double jumpering, checking & replacement of jumpers if necessary.
- f)Repairing of conductor, earth wire if necessary
- g) Watch and ward of the entire line.
- h) Replacement and restoration of all theft materials.
- i) Pollarding of trees.
- j) Tower footing protection
- k) Jumper tightening, replacement of jumpers if any.
- I) Clearing of bird nests etc.
- 2. Responsibility of the contractor
- a) The firm / contractor have to inspect the line thoroughly before submission of EOI.
- b) If line becomes breakdown due to any reason the firm should mobilize their gang for patrolling within one hour of its occurrence.
- c) After identification of the faults the firm shall mobilize their gang with T&Ps and restore at the minimum time possible.
- d) The line should be made available for equal to or more than 98% of the time of yearly Page 11 of 23

basis for evacuation of power.

- e) The contractor shall arrange the insurance to their workmen engaged for maintenance/restoration of the line at his own cost.
- f) The contractor shall be responsible for any accidents/misshapen during the work.
- g) The contractor shall have to submit the names along with the identification proof of the workmen before the engineer-in-charge.
- h) The contractor shall have to submit the proof of payments made to their workmen before the engineer-in-charge along with the bills.
- 3. Modalities of the restoration of breakdown work.-
- a) All the materials like GI angles, insulators, conductors, Earth wires, H/W filling, etc. are to be collected by the contractor from near by OPTCL stores at his own cost.
- b) If any major B/D is found Jumper should be reopened at Loc No-78 with consultation of T.L S/D,RKL for getting immediate P/S to Bhalulata.
- 4. Responsibility of OPTCL
- a) The Engineer-in-Charge of OPTCL shall inspect the line in phased manner.
- b) If the contractor/firm fails to attend the breakdown OPTCL will take up the work and the expenditure incurred as per actual for restoration with supervision charges @22% of actual expenditure shall be deducted from the bills / security deposit of the firm.

5. Security Deposit:-

The L-1 or the approved firm is required to deposit security deposit @10% of the total contract price in shape of demand draft or Bank Guarantee in the approved format of OPTCL within 15 days of award of the contract & before the execution of the work. The Bank Guarantee shall be valid beyond two months of completion of routine maintenance work.

OPTCL will not pay any interest on the security deposit. If the contractor/firm fails to execute this work or deviates from the terms and conditions of the contract, the security deposit shall be forfeited by OPTCL.

6. Validity of tender:-

The tender shall be valid up to 180 days from the date of the opening of the bid/specification.

9. Price:-

The price, quoted by the firm / contractor should be firm. Income tax and other statutory taxes, except service tax shall be deducted from the bills of the firm as per prevailing norms. Service tax shall be paid extra by OPTCL as per norms.

- 10. Payment:-The routine maintenance charges shall be paid on successful availability of the line i.e. 98% of total period on quarterly basis.
- 11. Agreement:-The contractor/firm has to do an agreement, in the approved format of OPTCL, with the engineer-in-charge, after the issue of the work order and before the execution of the work.
- 12. Penalty:-If the firm/contractor failed to made available the line 98% of the total period, penalty @ ----% on routine maintenance & operation charges shall be deducted. The availability shall be calculated on yearly basis.
- 13. Attending of Restoration and Break down work-

It is the sole responsibility of the contractor to take line clear permission from the engineer-in-charge and then take up the restoration and breakdown works. After completion of the restoration and breakdown work, the firm has to return line clear permission to the engineer-in-charge, with a declaration that the line is ready for charging.

14. Outright Rejection of Tender.

Tenders shall be out rightly rejected if they are not complying with the following requirements:

- a) Firms/Contractor down loaded the specification from the website of OPTCL but shall deposit the cost of specification while submitting the specification.
- b) The EOI shall be submitted in persons or by Regd. Post with A.D.
- c) The EOI shall not be submitted telegraphically or by FAX.
- d) The prescribed Earnest Money Deposit shall accompany the EOI.
- e) The EOI shall be kept valid for a period of 180 days from the date of opening.
- f) The Firms/Contractors having any pending legal suit against OPTCL.

g) The Firms /Contractors shall be submitted HT/EHT license, IT PAN, VAT clearance certificate, S.T. Registration certificate.

15. SAFETY PRACTICE:-

The Bidder must follow the OPTCL safety Rule while performing the work. The workmen must be provided with Safety Helmet, safety belt, safety shoe, etc by the contractor while performing the works .No deviation will be allowed and the consignee has got all power to stop the work at any time for the breach of safety practice.

16. Jurisdiction of the High Court of Odisha:
