(ii) The tender paper cost (Form fee) for an amount of **Rs 6,300/-** is to be paid for individual Lot.

## **SECTION-III**

### **GENERAL TERMS AND CONDITIONS OF CONTRACT [G.T.C.C.]**

#### **1. Scope of the contract:**

The scope of work covers the following activities.

- a) All the surfaces to be painted shall be free from rust.
- b) Removal of rusting & old paints are to be done and surfaces to be cleaned by making full use of mechanical tools along with manual scrubbing and wire brushing.
- c) Surface to be washed thoroughly and then dried properly or cleaned by cotton waste.
- d) One coat primer is to be applied by brush with Bison HB zinc phosphate primer of Berger/Asian make.
- e) Two coat painting to be applied by brush with Berger/Asian make Aluminium paint confirming IS 2339 over the primer coat.
- f) After final Aluminium painting, one coat of black enamel paint of Berger/Asian make confirming to relevant IS is to be applied by brush on the tower legs up to a height of 1 meter over the coping portion.
- g) Painting works of tower members are to be done up to bottom cross arm (M.S. Portion).
- h) Minimum two days gap should be maintained between two consecutive coats.

The painting work shall be done carefully in such a way that the paint shall not scale off or crinkle or shall be removed by abrasion due to normal handling and capable to withstand extremely of weather condition.

All materials required for painting including Berger paints, Asian Paints, thinners etc. tools and plants are to be supplied/ arranged by the contractor. The quality of primer & Berger/Asian make paints to be used for painting works of tower shall be examined for its genuineness by a committee constituting the Consignee, Divisional head, One Finance officer from Circle and TA to GM heading with General Manager, E.H.T (O&M) Circle, Chainpal prior to execution of the works by verifying purchase document made by the Contractor from the manufacturer/authorized dealers.

#### **2.0 Definition of terms:**

For the purpose of this specification and General Terms and Conditions of contract [GTCC], the following words shall have the meanings hereby indicated, except where otherwise described or defined.

- 2.1 "The Purchaser" shall mean the General Manager, EHT (O&M) Circle, Chainpal for and on behalf of ODISHA POWER TRANSMISSION CORPORATION LTD., Bhubaneswar.
- 2.2 "The Engineer" shall mean the Engineer appointed by the Purchaser for the purpose of this contract.
- 2.3 "Purchaser's Representative" shall mean any person or persons or consulting firm appointed and remunerated by the Purchaser to supervise, inspect, test and examine workmanship and materials of the equipment to be supplied.
- 2.4 "The Contractor" shall mean the bidder whose bid has been accepted by the purchaser and shall include the bidder's executives, administrators, successors and permitted assignees.

- 2.5 “Painting of Equipment” shall mean and include painting including supply of materials , labour charges etc. to be done under the contract by the Contractors.
- 2.6 “Contract Price” shall mean the sum named in or calculated the bid.
- 2.7 “General Condition” shall mean these General Terms and Conditions of Contract.
- 2.8 The Specification” shall mean both the technical as well as commercial parts of the specification annexed to or issued with GTCC and shall include the schedules .
- 2.9 “Month” shall mean “Calendar month”.
- 2.10 Writing” shall include any manuscript, type written, printed or other statement reproduction in any visible form and whether under seal or under hand.
- 2.11 “FOR Destination costs” shall mean the cost at our work site. The cost is inclusive of all taxes & duties etc. , but excluding Service tax.
- 2.12 The term “Contract document” shall mean and include GTCC, specifications, form of tender, Notice Inviting Tender, covering letter, schedule of prices or the final General Conditions, any special conditions, applicable to the particular contract.
- 2.13 Terms and conditions not herein defined shall have the same meaning as are assigned to them in the Indian Contract Act, failing that in the ODISHA General Clauses Act.

3. **Manner of execution:**

The works awarded should be commenced from 15 days of the award of the contract and completed within 2 months ( i.e.60 days). If the work could not be completed within scheduled date due to want of Shut down, hence completion period may be extended on written request of the tenderer.

All materials required for painting including Berger paints, Asian paints, thinners etc., tools and plants are to be supplied / arranged by the contractor. The quality of primer & burger/Asian make paints to be used for painting works of transformer shall be examined for its genuineness by verifying purchase document received from the manufacturer/authorized dealer by a committee constituting the Consignee, Divisional head, One Finance officer from Circle and TA to GM heading with General Manager, E.H.T (O&M) Circle, Chainpal prior to execution of the works.

4. **Language and measures:**

All documents pertaining to the contract including specifications, schedule, notices, correspondence, operating and maintenance instructions or any other writing shall be written in English language. The metric system of measurement shall be used exclusively in this contract.

5. **Right to reject/accept any tender:**

The Purchaser reserves the right either to reject or to accept any or all tenders if the situation so warrants in the interest of the OPTCL. Orders may also be split up between different Tenderers on individual merits of the Tenderer. The Purchaser has exclusive right to alter the quantities of work at the time of placing final work order.

6. **Completion of work**

The works awarded should be commenced from 15 days of the award of the contract and completed within 2 months (i.e. 60 days) from the date of issue of work order.

7. **Force Majeure:**

The Contractor shall not be liable for any penalty for delay or for failure to perform the contract for reasons of force majeure such as acts of god, acts of the public enemy, acts of Govt., Fires, floods, epidemics, Quarantine restrictions, strikes, Freight Embargo and provided that the Contractor shall within Ten (10) days from the beginning of delay on such account notify the purchaser in writing of the cause of delay. The purchaser shall verify the facts and grant such extension, if facts justify .

8. **Extension of time:-**

If the Completion of work is delayed due to reasons beyond the control of the Contractor, the Contractor shall without delay give notice to the purchaser in writing of his claim for an extension of time. The Purchaser on receipt of such notice may or may not agree to extend the contract period date as may be reasonable but without prejudice to other terms and conditions of the contract.

9. **Guarantee period: -**

(i)The work done by the contractor shall be guaranteed for a period of 12 months from the date of completion of work against any bad materials used and bad workmanship done for the work. The above guarantee certificate shall be furnished to the ordering authority for his approval . Any defects noticed during this period shall be rectified by the contractor ,free of cost to OPTCL within one month, upon written notice from OPTCL provided such defects are due to bad materials used and bad workmanship failing which provision of clause-11 (iii) shall apply.

(ii)The work failed or found defective during the guarantee period shall have to be guaranteed after rework for a further period of 12 months from the date of completion of work. The Bank Guarantee is to be extended accordingly without any financial burden to OPTCL.

10. **SERVICE TAX REGISTRATION No., PAN CARD & HT/MV LICENSE:**

Scanned copies of PAN, Service Tax Registration no. & HT/MV License valid on the date of opening of tender should be uploaded along with tenders, failing which the tender will be rejected. The contractor or their authorized representatives should produce the original documents for verification within 10 days from the date of opening of tender. Those who fail to produce the same and found not to be valid at the time of verification, their tenders will be rejected.

11. **B.G. towards security deposit, 100% payment and performance guarantee:**
